The reference to handicaps in all cases refers to *Playing Handicaps*. Strokes must be taken according to the Handicap Stroke Index.

Match Play Singles Full difference between the handicaps of the players
 Foursomes 1/2 difference between aggregate handicaps of each side
 Four-ball Back marker to concede strokes to the other 3 players based on 3/4 of the difference between the full handicaps

Stroke Play Singles Full handicap
 Foursomes 1/2 aggregate handicap of partners
 Four-ball Each partner receives 3/4 of full handicap (better ball)

Par Singles Full handicap
 Foursomes 1/2 aggregate handicap of partners
 Four-ball Each partner receives 3/4 of full handicap (better ball)

Stableford Singles Full handicap
 Foursomes 1/2 aggregate handicap of partners
 Four-ball Each partner receives 3/4 of full handicap (better ball)

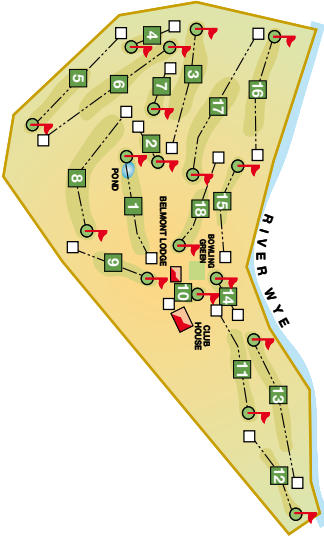
LOCAL RULES

1. **Out of Bounds (Rule 27-1)**
 - a) Beyond the perimeter fence and hedges.
 - b) On or over the line identified by white marker posts to the right of the 11th and 12th holes and other areas identified by white marker posts.
 - c) Car paths and roadways below the 9th green and behind the 18th green.
2. **Water Hazards (Rule 26)**
 - a) The River Wye with its banks, and the pond and ditch along with their banks as identified by red marker posts to the rear of the 17th green, are lateral water hazards.
 - b) All other ponds and ditches identified by yellow marker posts are deemed to be water hazards.
3. **Ground Under Repair (Rule 25-1)**

Kits made by a tractor, draining ditches, drainage holes and channels, ground identified by white lining and/or topped off areas marked with a GUR notice, are deemed to be ground under repair.
4. **Immovable Obstructions (Rule 24-2)**

All pathways, shelters, fences, permanently fixed marker posts (excluding OOB posts) and winter trees are deemed to be immovable obstructions.
5. **Movable Obstructions (Rule 24-1)**

Stones on any part of the course,



including bunkers, which are not embedded, are deemed to be movable obstructions.

Temporary Local Rules

These, (as displayed in the Professional's Shop) are effective from the date published.

Environmentally Sensitive Areas (ESA)

The ponds on the 1st and the 15th hole along with their banks, as identified by yellow marker posts, are deemed Environmentally Sensitive Areas (ESA) and water hazards from which play is prohibited. There should be NO entry into the area and where it is known or virtually certain that a ball lies within the area it is deemed LOST. A Player should proceed under Rule 26-1.

Penalty for breach of Local Rule:

Match Play - Loss of Hole;
Stroke Play - Two Strokes.

Practice Ground

The practice ground, the area enclosed by the line of trees at the back of the 15th green, the line of trees to the left of the 16th fairway, the pathway leading from the 16th green to the 17th tee, and the line of trees and stakes to the left of the 17th fairway, is an integral part of the course. Balls lying in this area should be played as they lie. Practice is permitted within this area.
